

NOTICE OF MEETING


FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 151

The Board of Directors of Fort Bend County Municipal Utility District No. 151 will hold a regular meeting on Monday, July 22, at 12:00 p.m., at the offices of Inframark LLC, 2002 West Grand Parkway North, Suite 100, Katy, TX 77449, to discuss and, if appropriate, act upon the following items:

1. Comments from the public.
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event, the item will be removed and placed on the Non-Consent Agenda.
 - a. approve minutes;
 - b. garbage collection and recycling matters;
 - c. tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills;
 - d. authorize delinquent tax attorney to proceed with collection of delinquent taxes;
 - e. discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference;
 - f. review Arbitrage Rebate Report for the Series 2019 Refunding Bonds;
 - g. maintenance and mowing of District facilities, environmental monitoring of facilities, fees for violation, and hearing and opportunity for appeal for withholding tap service for nonpayment of backcharges;
 - h. report on lake maintenance; and
 - i. fire protection services matters, including maintenance of fire station.

4. Additional tax assessment and collection matters, including discuss First Amendment to Contract for the Assessment and Collection of Taxes, and take appropriate action.
5. Adopt Resolution Regarding Development Status for 2024 Tax Year.

 - f. 2024 Wastewater Treatment Plant Improvements;
 - g. update on bond application no. 16 and park bond application, including adopt Resolution Authorizing Application to the Texas Commission on Environmental Quality for Approval of Projects and Bonds; and
 - h. deeds, related environmental proposals, easements, encroachment agreements, right of entry agreements, conflicts waivers, and requests for service or utility commitments.
8. TCEQ Phase II Small MS4 General Permit matters, including status of compliance, necessary training, and public comment.
 9. Park and landscape maintenance matters, including:
 - a. proposals for additional work; and
 - b. resident or Firethorne Community Association requests, including:
 - i. approve Temporary Construction Access Agreement.
 10. Park and landscaping development matters.
 11. Operation of District facilities, including:
 - a. billings, repairs, maintenance, and backcharges, and customer correspondence and appeals;
 - b. discuss DuPont and 3M Class Action Settlements, and authorize appropriate action; and
 - c. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
